Third-Party Scrutineer Report



Procedures and Findings

We have performed the procedures described below, which were agreed upon with DotAsia Organisation Limited, on monitoring the voting procedures and results.

- 1. We assessed and suggested third-party online voting platform by reviewing the third-party online voting platform on security and integrity
 - Two trials had been taken from 11th to 19th of April 2024 on testing the procedures and results of the online voting platform ("BigPulse"). Further eleven trials, in a smaller scale, were arranged from 19th to 23rd April 2024 for testing tie-breaker case.
 - System testing has been performed for the followings:
 - a. Timeline (including test vote open and close)
 - Roles of the Election Managers (Primary Poll Election Manager acting as "Election Chair", Election Compliance Admin and Scrutineer)
 - Voting validation
 - Results validation

NomCom Roles & Responsibilities

- NomCom is tasked to:
 - Establish and enforce Election Code of Conduct
 - 2. Vetting and confirming eligible nominees in a DotAsia Board Election (based on DotAsia Articles of Association)
 - 3. Selection for appointment one individual to the DotAsia Board (to enhance ability to obtain knowledge and skills, especially where there may be gaps, on the Board)
 - 4. Compiling a Nominations Report

- NomCom is delegated with the power to:
 - Complete tasks independent from the DotAsia Board
 - Determine the non-compliance or ineligibility of a Board Election candidate
 - (All Board candidates expressly waive any right to damages caused directly or indirectly by the decision of the NomCom)





Election Code of Conduct

- To be maintained and confirmed by the Nomination Committee (NomCom)
- Violation of Election Code of Conduct may lead to exclusion of Nominee
 - 1. Generally Expected Standards of Behaviour
 - 2. Unacceptable Behaviours
 - 3. Reporting Non-Compliance
 - 4. Evaluation and Decisions on Reported Non-Compliance
 - 5. Consequences of Non-Compliance or Ineligibility

- Finalization of Election Code of Conduct: March 19, 2024.
 - Mar 21, 2024 (Thu): Nomination Period Began













NomCom Candidate Eligibility Vetting Process

- Nominations Period Close: Apr 9, 2024
 - 96hrs Dispute Resolution Period
- Information and Declarations from Nominees:
 - Acceptance of Candidacy
 - Declaration on meeting basic eligibility requirements
 - Abidance by the DotAsia Code of Conduct & Board Confidentiality Guidelines
 - Demonstrate participation in and familiarity with DotAsia works
- NomCom determination on eligibility:
 - DotAsia Team report on validity of declarations (on best efforts basis)
- Publishing of Nominations Report
 - DotAsia AA 23(2): A Nominations Report including all confirmed eligible nominees shall have been sent to the Board after the nomination period and before the voting period













Nomination Period Results (Nominations Report)

- NomCom reviewed five members-nominated candidates and confirmed all five candidates as eligible
 - Sponsor Member (3 candidates for 2 vacancies) Voting Period commenced on April 29, 2024 - May 8, 2024 23:59 UTC.
 - Co-Sponsor Member (2 candidates for 2 vacancies)













NomCom Appointed Board Director

- Identifying potential NomCom Appointed Candidates:
 - Board Skills Matrix/Survey (identifying any gaps)
 - NomCom ranked preferences of potential candidates
 - NomCom approached potential candidates to assess willingness to serve
- Candidate completes Candidacy Acceptance email
 - Similar to acceptance of nominations in the electoral stream (Code of Conduct / Confidentiality / familiarity, etc.)
 - DotAsia staff validates Candidacy statement (on best efforts basis)
- NomCom finalizes appointment
 - Decision based on Candidate Checklist + Staff validation
 - Nomination Report published













NomCom Nominated Board Member

- In accordance with the Composition of the Board of Directors specified in Article 3(5) of Part B(2) of the DotAsia Articles of Association, one (1) Director shall be nominated by the Nomination Committee and appointed by the Board of Directors and seated at the annual general meeting of the Company in accordance with the provisions of Article 23.
- Nomination Committee has nominated Jo-Fan YU.


