The term of the Election Committee and Nomination Committee for the Board Elections 2025 is from Dec 13, 2024 until the completion of the Board Elections 2025. In accordance with the <u>Board</u> <u>Elections Procedures (BEP)</u>, the Election Committee will oversee the election process, declare the election results, and resolve procedural disputes, if any.

The Nomination Committee will determine the eligibility of candidates, establish and enforce an Elections Code of Conduct, and nominate a person for appointment to the DotAsia Board directly every 3 years (an appointment was made in the Board Elections 2024 with the appointee serving for 3 years, therefore this year there will be no appointment).
